# City of Boyden Minutes of Monthly Council Meeting January 14, 2019

Mayor Laryl Koerselman called the meeting to order at 5:30 p.m. Council members present were Dale Winter, Kim Ochsendorf, Justin Beukelman, and Bob Koerselman and Nathan Alexander.

Others present were city employees Tami Kamies and Blake Snieder.

Mayor or Council Comments: Council man Beukelman made a motion to approve the ambulance training for Brent Steven, the city looking in to purchasing a few plastic tables for the Demco Center, and to have DGR proceed with the north route for the new Sewer Line Project. Ochsendorf supported. Motion carried 5-0.

Resolution 2019-01 naming Tami Kamies as city clerk, allowing her to pay bills, naming De Koster and De Koster as city attorney, Citizen State Bank as the depository, and the Hull-Index Reporter as the city's newspaper. Roll call: Ayes–5, Nays-0, Absent–0. Resolution passed.

Resolution 2019-02 setting the mileage rate to follow the rate set by the IRS. Roll call: Ayes-5, Nays-0, Absent-0. Resolution passed.

Resolution 2019-03 to enter into a contract with Hospers Sanitation for the collection of garbage/recycling. Roll call: Ayes-5, Nays-0, Absent-0. Resolution passed.

Consent Agenda: Councilman Beukelman made a motion to pass the December Financials, the minutes from the December 12 meeting, the committees that are in place, and the bills in the amount of \$57,472.12, Winter supported. Motion carried 5-0.

A discussion was had regarding the city co-signing the Boyden Economic Development Corp. loan for the Demco 1<sup>st</sup> Addition. The city will look into entering in contract with the BEDC regarding this loan. This will be tabled until a later meeting.

The council discussed items to be budgeted for. B. Koerselman made a motion that the city will budget for \$6,250 to be given to the fire department for the purchase of their new fire truck. Winter supported. Motion carried 5-0. The budget is set to be approved at the February council meeting at which the date for the public hearing will be set.

With no further business Alexander made a motion to adjourn the meeting. Winter supported. Motion carried 5-0. Meeting was adjourned at 7:50 p.m.
