Mayor Laryl Koerselman called the meeting to order at 5:30 p.m.

Council members present were Justin Beukelman, Dale Winter, Bob Koerselman, and Nathan Alexander. Kim Ochsendorf was absent.

Others present were Roger Nelson, Lisa Nelson, and city employees Tami Kamies and Blake Snieder.

Blake presented the cities maintenance report which included the discussion of what streets we will repair this summer.

Roger and Lisa Nelson came to discuss the alley by their house and what we can do to fix the issue of water collecting in that alley. Nelson's will contact Boer & Sons to see how they can create a flow for the water to run through the back yard of the Nelson's property to eliminate the current water issue.

The council discussed the easements for the sewer project. The city will be in contact with DGR to have them help with meeting the needs that are being requested by the property owners.

The city will verify that the residents to the west of the Demco 1st Addition have their trees, bushes, and buildings within their property lines.

Consent Agenda: Councilman Winter made a motion to pass the March Financials, the minutes from the March 11th meeting, and the bills in the amount of \$133,460.48. B. Koerselman supported. Motion carried 4-0.

Beukelman made a motion to raise the city's credit card limit from \$1,500.00 to \$2,500.00. Winter supported. Motion carried 4-0.

Resolution 2019-02 setting the public hearing for the FY19 Budget Amendment was introduced by councilman Beukelman. Councilman Winter seconded the motion. The public hearing is set for May 13, 2019. Motion carried 4-0.

B. Koerselman made a motion that the city go ahead and lease a new copier for both the city office and library. Alexander supported. Motion carried 4-0.

The Boyden Ambulance requested the approval to allow Laiken Koerselman to join as a Junior EMT. Alexander made a motion to approve the request. Winter supported. Motion carried 3-0. B. Koerselman abstained from the vote.

Justin Beukelman presented to the council the plans the park revitalization committee has for park improvements this summer. The east park main bathrooms will be redone along with a few other minor repairs or changes.

With no further business B. Koerselman made a motion to adjourn the meeting. Alexander supported. Motion carried 4-0. Meeting was adjourned at 7:50 p.m.
