City of Boyden Minutes of Monthly Council Meeting May 14, 2018

Mayor Laryl Koerselman called the meeting to order at 5:30 p.m. Council members present were Dale Winter, Bob Koerselman, Kim Ochsendorf, Art Van Bruggen, and Justin Beukelman.

Others present Les Starkenburg as well as city employees Tami Kamies and Blake Snieder.

Mayor and Council Comments – It was discussed that the city would make community garden plots on the city property along main street between the Boyden Testing Service and Citizen State Bank. There also was a discussion of what the city wants to do with equipment that is no longer being used.

Consent Agenda – Beukelman made a motion with a second from Winter for the following items. The April 2018 financials and the bills totaling 41,431.17 were approved. The building permit for Co-op Gas & Oil, the tobacco permit for Pit Row, the gambling permit for the Boyden Bash, and the FY2019 Sherriff contract were also approved. Motion passed 5-0

Mayor Koerselman opened the Public Hearing. B. Koerselman introduced Resolution 2018-09 amending the Annual Budget for Fiscal Year Ending June 30, 2018. There were no written or oral comments from the public. Van Bruggen seconded the motion to adopt. The motion carried 5-0. Mayor Koerselman closed the public hearing.

Ochsendorf made a motion to waive the first two readings and to approve the third reading of Ordinance 2018-101 amending the City Code of Boyden, Iowa, By Amending Sections 66.03 and 66.05 (Load Limits Upon Certain Streets). Van Bruggen seconded the approval of the third reading. Motion was passed 5-0.

Les Starkenburg presented to the council that the Sioux County Board of Supervisors passed a resolution stating that Boyden will be receiving \$10,000 per year for the next 10 years for ambulance equipment replacement.

The city will be redoing the Boyden sign that is on highway 18 just south of Main Street. The main street businesses in town will be receiving a letter regarding their interest in having the businesses name on the sign.

Discussion was had regarding the current water and sewer rates. The rates will be looked at after the fiscal year 2018 is finished.

Next meeting is June 11 at 5:30.

With no further business B. Koerselman made a motion to adjourn the meeting. Ochsendorf supported. Motion passed 5-0. The meeting adjourned at 7:45 p.m.
