Maintenance Report: The city will purchase new LED lights for the Demco Center as well as price out a new door for the south entrance of the Demco Center. Blake will be cutting down the dead trees in the park and plan to replace with new trees this fall.

Consent Agenda: Councilman Ochsendorf made a motion to approve the May Financials, the minutes from the May 11 minutes, the bills in the amount of \$121,838.95, and a building permits for David Kooiker. Beukelman supported. Motion carried 5-0.

Beukelman made a motion to have William's & Company do the cities FY20 annual examination. Alexander support. Motion carried 5-0.

Deryck and Alex Hoogendoorn have put up a fence around their back yard as well as supply the city with their liability insurance for their property. A signature is needed from Deryck & Alex on the Vicious Dog Agreement. The deadline for them to meet compliance is the 10th of June.

The city will look in to switching their current loan with Lyon & Sioux Rural Water to a loan through the bank with lower interest. Winter will contact the bank and we will relook at this in the July council meeting.

Beukelman made a motion to make an increase to the city sewer rates. For residents the minimum fee will increase .50 cents and .40 cents per one thousand gallons. Industrial users minimum fee will increase 1.00 and .40 per one thousand gallons. The sewer project fee will also increase 2.50 per residence. Alexander supported. Motion carried 5-0.

With no further business Ochsendorf made a motion to adjourn the meeting. Winter supported. Motion carried 5-0. Meeting was adjourned at 7:05 p.m.
