City of Boyden Minutes of Monthly Council Meeting, July 13, 2020

Mayor Laryl Koerselman called the meeting to order at 5:30 p.m.

Council members present were Robin Jungers, Dale Winter, Kim Ochsendorf, and Nathan Alexander. Justin Beukelman was absent.

Others present were Brent Steven, Brad Wielenga, and city employees Blake Snieder and Tami Kamies.

Brent stated that Chris Diekevers, Koby Jones, and Laiken Koerselman would like to take the EMT course. Ochsendorf made a motion to approve them taking the EMT course. Alexander supported. Motion carried 4-0.

Jungers made a motion to pass Resolution 2012-12 to change the ambulance rates to match the recommended rates from Wellmark. These will take effect July 1, 2020. Winter supported. Motion carried 4-0.

Brad with OC Sanitation would like to change the date for the garbage pickup. His recommendation is to have recycling to remain the 1st and 3rd Wednesday of every month and to have garbage pickup up every Thursday. Ochsendorf made a motion to follow his recommendations and that the change will take effect on August 1st. A notice will be published in the paper, in the city newsletter, Facebook, and Boyden cable. Alexander supported. Motion carried 4-0.

Maintenance Report: A glass door at the Demco Center will be getting repaired. The water tower had an inspection. The city will look in to possibly getting the inside and outside of the water tower repainted. It will be put on the next months agenda for discussion. Blake will look in to numbers to get a sprinkler system in the outfield of the softball diamond. We would repurpose the water used in the splash pad. The city continues to move through the process for the Wastewater Treatment Facility.

Consent Agenda: Councilman Ochsendorf made a motion to approve the June Financials, the minutes from the June 8 minutes, the bills in the amount of \$94,851.52. Winter supported. Motion carried 4-0.

Councilman Ochsendorf made a motion that the city refinance their current loan with Lyon-Sioux Rural Water with a loan through Citizen State Bank. This will take effect immediately. Jungers supported. Motion carried 4-0.

The city will be adding another warning siren in the town. Jungers made a motion that the city move forward with ordering the new siren and getting it scheduled to be put up. Alexander supported. Motion carried 4-0.

Alexander made a motion to pass Ordinance 2020-101 Amending Chapter 99, Section 99.02 of the Code of Ordinances regarding the sewer rates. Winter supported. The 1st and 2nd readings were waived with a roll call vote of 4-0-1. The new rates will take effect the next billing cycle after publication.

A motion was made by Jungers to set the date for the public hearing to vacate the alleyway between parcel 0526401006 and 052641005 and the portion of Prairie Street immediately north of parcel 0526401005 up to Sherman Street right-of way for August 10 at 5:30 pm. Alexander supported. Motion carried 4-0.

The city received a status update that the sewer main replacement project is now complete.

A meeting will be set up with FCS to update on what they are doing to prevent dust and noise within the city.

Ochsendorf made a motion to pass Ordinance 2020-102 Amending Chapter 105, Section 105.9 of the Code of Ordinance regarding Waste Storage Containers. Winter supported. The 1st and 2nd readings were waived with a roll call vote of 4-0-1.

A motion was made by Alexander to change the ordinance regarding fireworks. The dates within the ordinance for shooting off fireworks will be changed to July 1st through July 7th and December 30th through January 1st. Jungers supported. Motion carried 3-1.

With no further business Alexander made a motion to adjourn the meeting. Jungers supported. Motion carried 4-0. Meeting was adjourned at 6:55 p.m.
