City of Boyden Minutes of Monthly Council Meeting March 11, 2019

Mayor Laryl Koerselman called the meeting to order at 5:30 p.m. Council members present were Kim Ochsendorf, Justin Beukelman, and Dale Winter. Bob Koerselman and Nathan Alexander were absent Others present were Bill Honkomp, Brad Wielenga, and city employees Tami Kamies and Blake Snieder.

Mayor Koerselman opened the public hearing at 5:30.

Mayor Koerselman read the Resolution 2019-06 authorizing the disposal of certain real property in the City of Boyden described as the fire station. The fire station is being given to the Board of Control-Boyden Area Fire Department, for the public purpose of providing fire protection to the City of Boyden and surrounding areas. Councilman Beukelman made a motion to approve the resolution. Ochsendorf supported. Motion passed 3-0.

Mayor Koerselman read Resolution 2019-11 approving and authorizing execution of a Development Agreement by and between the City of Boyden and Boyden Economic Development Corporation. There were no written or oral objections. Councilman Ochsendorf introduced the resolution and motioned that the resolution be adopted. Winter seconded the motion. Roll call 3-0.

Mayor Koerselman read Resolution 2019-10 adopting the annual budget for Fiscal Year ending June 30, 2020. With no written or oral comments councilman Beukelman introduced the resolution and made motion to adopt FY20 budget. Winter seconded the motion to adopt. Roll call 3-0.

Public hearing was closed at 5:40.

Brad Wielenga with OC Sanitation and Bill Honkomp with Hospers Sanitation presented that Brad will be buying out the garbage business from Bill. Brad will take over starting June 1. With the change of ownership, the city will be moving forward with purchasing the larger garbage and recycling containers that each household will be provided with. Beukelman made a motion to move forward with Brad and OC Sanitation and having them take over the garbage and recycling services for Boyden. Ochsendorf supported. Motion passed 3-0.

Consent Agenda: Councilman Beukelman made a motion to pass the February Financials, the minutes from the February 11th meeting, and the bills in the amount of \$62,136.50, Ochsendorf supported. Motion carried 3-0.

FCS has donated money to put towards the purchase of some plastic tables for the Demco Center. Winter made a motion that the city match what FCS has donated and to purchase 8 tables. Ochsendorf supported. Motion passed 3-0.

The city will be taking applications for summer help.

Ochsendorf made a motion to approve the proposed mailbox policy regarding the replacement if the mailbox is knocked down or broken during the snow removal process. The city will pay up to \$50.00 to replace a mailbox and up to \$75.00 to replace the mailbox and post. It is the responsibility of the home owner to make the repairs and make sure they are incompliance with the Postal Service guidelines. When receipts for the repair are given to the city, the city will then issue a check. Winter supported. Motion carried 3-0.

With no further business Ochsendorf made a motion to adjourn the meeting. Winter supported. Motion carried 3-0. Meeting was adjourned at 6:50 p.m.
