Minutes of Monthly Council Meeting
May 13, 2019

Mayor Laryl Koerselman called the meeting to order at 5:30 p.m.

Council members present were Justin Beukelman, Dale Winter, Bob Koerselman, Kim Ochsendorf and Nathan Alexander.

Others present were Travis Hofmeyer, and city employees Tami Kamies and Blake Snieder.

Mayor Koerselman opened the meeting with the public hearing for a vicious dog at 5:30.

Travis Hofmeyer presented to the council that he does in fact agree that two incidents that the dog has bitten people are correct. Councilman Beukelman motioned that the dog needs to be removed from the residence within 72 hours in accordance with the city ordinance. B. Koerselman seconded the motion. Motion carried 4-0. Alexander abstained his vote.

The public hearing was closed at 5:43.

Blake presented to the council that we hire the mowing of the cemetery out to another individual. Beukelman made a motion that the city hire Brian Nilles to mow the cemetery during the summer months. Ochsendorf seconded. Motion carried 5-0.

Consent Agenda: Councilman Beukelman made a motion to pass the April Financials, the minutes from the April 8 & 22 meeting, the bills in the amount of \$31,547.47, the tobacco application for Pit Row, and the building permits for Brent Dokter, Daina Howrey, Thomas Hamling, and Veronica Gonzalez. Alexander supported. Motion carried 5-0.

Councilman Ochsendorf introduced the Resolution 2019-13 to amend the annual budget for fiscal year ending June 30, 2019. B. Koerselman supported. Motion carried 5-0.

Resolution 2019-14 directing the clerk to publish notice of public hearing on the adoption of the proposed "Code of Ordinances of the City of Boyden". Roll call- ayes 5, nays 0. Motion carried 5-0.

The council discussed the possibility of doing another street project. They will look in to what the cost of a street project will be to try and anticipate when the best time to do one.

Beukelman made a motion to hire Marci Bergstrom to clean the park from May thru September. Ochsendorf supported. Motion carried 4-1.

The city will look in to the possibility of providing bussing for the summer rec program.

B. Koerselman made a motion that the city will enter into a lease with Art Van Bruggen for the use of a Bobcat Tool cat. Alexander supported. Motion carried 5-0.

With no further business B. Koerselman made a motion to adjourn the meeting. Winter supported. Motion carried 5-0. Meeting was adjourned at 7:45 p.m.
